NOTIFICATION

Whereas the draft of the Karnataka State Police Including Ministerial Services (Recruitment) (Amendment) Rules, 2020 was published as required by clause (a) of sub-section (2) of section 3 read with section 8 of the Karnataka State Civil Services Act, 1978, (Karnataka Act 14 of 1990) in Notification No. HD/38/PPA/2020-PS_B, Bengaluru, dated: 16.06.2020 in Part IV-A, No. 207 of the Karnataka Gazette Extra-ordinary dated: 17.06.2020, inviting objections or suggestions from all the persons likely to be affected thereby within fifteen days from the date of its publication in the Official Gazette.

Whereas, the said Gazette was made available to the public on 17.06.2020;

And whereas objections and suggestions received within the period specified above have been examined.

Now, therefore, in exercise of the powers conferred by sub-section (1) of section 3 read with section 8 of the Karnataka State Civil Services Act, 1978 (Karnataka Act No. 14 of 1990), the Government of Karnataka, hereby makes the following rules, namely:-

RULES

1. Title and commencement.-(1) These rules may be called the Karnataka State Police Including Ministerial Services (Recruitment) (Amendment) Rules, 2020

(2) They shall come into force from the date of their final publication in the Official Gazette.

2. Amendment of Schedule .-In the Karnataka State Police Including Ministerial Services (Recruitment) rules, 2004 in the schedule for the entries relating to the category of posts of "Police Constable (Civil) (Men and Women)" at serial No 14 the following shall be substituted, namely:-

		<p>Director General & Inspector General of Police as coordinator Police recruitment.</p> <p>Method of Selection Direct Recruitment and in Service Direct Recruitment</p> <p>After getting prior approval of the Director General and Inspector General of Police for the number of vacancies to be filled, the Selection Authority of the District concerned, shall give wide publicity by publishing the Notification in the Official Gazette and also advertising in atleast two leading Newspapers having wide circulation and invite application from all eligible candidates in such forms as may be specified by it for the purpose of recruitment under these rules. It shall also give publicity through All India Radio and Doordarshan in this regard.</p> <p>The Selection Authority shall on receipt of the applications in response to the Notification, prepare a list of eligible candidates and selection shall be made in the following manner, namely:</p> <p>Written Examination: There shall be a common written test for all the Districts or Commissionerates either in Kannada or English carrying 100 Marks. The questions shall be of Objective type with multiple choices. It cannot however be operated for the vacancies created after issuing Appointment Orders.</p> <p>The final Selection List & Additional list shall valid till all vacancies notified are filled or until next notification whichever is earlier.</p> <p>Training: Selected candidates shall undergo training as specified by the DG and IGP from time to time. Those candidates who do not pass the prescribed tests are liable to be discharged.</p> <p>Probation: The candidates shall be on probation for two years and six months including the training period.</p>
