**NOTIFICATION**

Whereas the draft of the Karnataka Prison (Amendment) Rules, 2020 was published, as required, by section 63 of the Karnataka Prison Act, 1963 (Karnataka Act 33 of 1963) is hereby published as required by sub-section (1) of section 63 of the said Act in Notification No. HD 56 PRA 2020 dated: 23-06-2020 in Part-IV A page no. 2337 of Karnataka e-gazette dated: 09-07-2020, inviting objections and suggestions from all persons likely to be affected thereby on or before 23rd July 2020.

And whereas, the said Gazette was made available to the public on 10<sup>th</sup> July 2020.

And whereas the objections/suggestions were not received on the said draft.

Now, therefore in exercise of the powers conferred by section 63 of the Karnataka Prisons Act, 1963 (Karnataka Act 33 of 1963), the Government of Karnataka hereby omitting the following sub-rule namely:-

**RULES**

1. **Title and Commencement,-** (1) These Rules may be called Karnataka Prison (Amendment) Rules, 2020

(2) They shall come into force from the date of their final publication in the Official Gazette.

2. **Amendment of Rule 191,-** In rule 191 of the Karnataka Prison rules, 1974, in sub rule (3) in second proviso, clause (n) shall be omitted.
